

**ARCHBALD BOROUGH COUNCIL MEETING**  
**Minutes, January 14, 2015**

The meeting was called to order at 7:00 pm by President Joseph Simon. A moment of Silence was followed by the Pledge of Allegiance. Roll Call: Tomassoni, Munley, Williams, Shnipes, Jr. and Simon present. Grandinetti and Durkin not in attendance. Mayor Barrett was in attendance.

Mr. Hoover to address council regarding PAWC plans to replace water lines in the Riverside section of the Borough. Mr. Hoover did not attend, Mr. Simon stated new water lines with larger mains will be discussed.

**New Business**

Third Party Inspection procedures. Mr. Munley stated he feels contractors should be able to choose who they want. Mr. Simon stated the borough is looking out for the consumer and both BIU and NEI charge the same. Mr. Simon stated it will be on the agenda at the February 2015 meeting.

Tomassoni asked if the bough could do anything to help the elderly people with clearing the snow from their sidewalks. Mr. Simon stated the borough cannot go on private property and suggested the church, Lions club or Boy Scouts could maybe help out.

Munley had nothing at this time.

Williams stated the planning committee reviewed zoning ordinances and approved them. Mr. Williams stated a proposed new development called Woodberry Estates may be developed behind Wildcat Ridge. The 1<sup>st</sup> phase would have 16 lots.

Shnipes stated concerns about street lighting by Dipple house. Mayor stated she will chief look into it.

**Motions**

Motion by Shnipes, Jr. second by Munley to approve the minutes of the December 3, 2014 regular meeting and December 18, 2014 Special meeting. All in favor, motion carried.

Motion by Shnipes, Jr. second by Tomassoni to accept reports- Treasurer, Controller, Solicitor, Engineer, Building Inspector, Borough Manager and Mayor's Report. All in favor, Motion carried.

Motion by Munley second by Shnipes, Jr. authorizing payment of December 2014 general fund bills totaling \$76,190.20 and Memorial Park bill in the amount of \$176.08. Roll call vote, Tomassoni, Shnipes, Jr., Munley and Simon for it, Williams abstain. Motion carried.

Motion by Shnipes, Jr. second by Munley to appoint Tom Butler, John Binner, Matt Carter, Lewis Chirico, Gene Cholish, Joseph Farrell, Joseph Laboranti, Corey Lucas, Anthony Mercado, Turique Patrick, Matt Petrie, Stephanie Racht, and Alan Wright Special Police from February 1, 2015 to February 28, 2014 provided they are to be used only to replace a full time regular officer who cannot work due to allowable time off and not to exceed 33 shifts. All in favor, motion carried.

Motion by Williams to reduce the salary of Council members, the Mayor and the Controller to \$0.00 effective at the beginning of the next term of the member of Council, the Mayor and the Controller. No second motion dropped.

Motion by Munley second by Shnipes, Jr. to pursue the alternate storm water pipe location along Lackawanna Avenue in order to address the existing Nebraska problem. All in favor, motion carried.

Motion by Shnipes, Jr. second by Munley to adjourn. All in favor, motion carried.
