The meeting was called to order at 7:00 pm by President Randy Grandinetti. A moment of Silence was followed by the Pledge of Allegiance. Roll Call: Tomassoni, Mancuso, Hart, Owen and Shnipes, Jr. present. Munley absent. Mayor Barrett was in attendance.

Public Input


Motion by Shnipes, Jr., second by Tomassoni to adjourn. All in favor, motion carried.
