## Archbald Borough State of Emergency

Due to the Corona Virus pandemic The Borough of Archbald has declared a State of Emergency. Public access to all Archbald Borough public buildings, parks and playgrounds will be restricted beginning on Monday March 16, 2020 at 2:00 P.M. until further notice:

First and foremost, the health, safety and well-being of the residents of the Borough is our Number one priority. For that reason, the following restrictions are being put in place in order to protect the health and safety of the residents of Archbald Borough and the employees and volunteers of the Borough.

- Public access to the Archbald Borough Building, 400 Church Street, will be restricted until further notice. Any resident with business with the Borough Manager, Code Enforcement and Zoning Officer, will need to call the Municipal Building (570) 876-1800, or visit our website <a href="mailto:archbaldboroughpa.gov">archbaldboroughpa.gov</a> for general information. Going forward all business will be conducted by phone, mail or email. All borough meetings will be cancelled until further notice.
- Public access to the <u>Archbald Borough Police Department</u>, 400 Church Street will be restricted until further notice.

If you have an emergency and need a police officer, immediately call 911. Otherwise, call the non-emergency number at (570) 342-9111. Copies of police reports can be requested calling (570) 876-0426

Archbald Borough Tax Offices at the Borough Building and Eynon Hose Company will be closed. Real Estate Taxes can be mailed during this time to 400 Church Street, Archbald PA 18403 Attn: Tax Collector. If you need a receipt please indicate and a receipt via US Postal Service will be mailed. If you have any questions regarding taxes please call 570-876-3395.

• Public access to the Archbald Borough DPW Garage, 6 Export Lane will be restricted until further notice.

Any questions regarding garbage and recycling pick up can call (570) 876-1800 ext. 101.

Our Department of Public Works will also still be working during this time, and we ask that residents please disinfect trash cans and recycling bins to help protect our workers.

• Public access to the following Borough Parks and Recreational Facilities is restricted until further notice: Archbald Borough Gym, Laurel Street Park, Pike Street Part, Rock Street Park, Betty Street Park, Riverside Park, Venosh Park, Sturges Park, Nebraska Park and High School Plaza Park.

Public access to the Archbald Borough Historical Society will be restricted until further notice.

• Public access to all Archbald Borough Fire Departments and the Ambulance Building will be restricted until further notice.

If you have an emergency and need the fire department, immediately call 911. Otherwise, call the following non-emergency number (570) 342-9111.

While access is being restricted to the public, the Borough will continue to thoroughly clean and disinfect all Borough offices and Borough parks so they are ready for public use once the State of Emergency is lifted. We ask that you please follow all directives from the Centers for Disease Control (CDC) and the Pennsylvania Department of Health when it comes to the COVID-19 crisis.
