Tomassoni opposed. 5-1 vote, motion carried.

Motion by Owen, second by Munley to appoint Patrick Chelland and George Weitz Special Police from April 13, 2016 to December 31, 2016 provided they are to be used only to replace a full time regular officer who cannot work due to allowable time off and not to exceed 33 shifts per month. All in favor, motion carried.

Motion by Owen, second by Hart to approve Resolution supporting Senate Bill 1340 and House Bill 1272 allowing local police use of radar timing devices. All in favor, motion carried.

Motion by Munley, second by Mancuso to solicit bids for cleaning of the Borough Building. All in favor, motion carried.

Motion by Hart, second by Mancuso to reject Lackawanna Tax Claim Bureau Offer of \$500.00 for Lot 46, Valley View Estates. All in favor, motion carried.

Motion by Munley, second by Mancuso to authorize painting of Council Chambers and the purchase and placement of a Centennial logo and plaques recognizing the Borough's past Mayors, Council members and Chiefs of Police for a cost not to exceed \$1,300.00. All in favor, motion carried.
