Roll call vote, Owen, Burke, Gilgallon, Hart, Grandinetti and Simon for, Mancuso against. 6-1 vote for it, motion carried.

Motion by Owen, second by Gilgallon to **NOT** draft an Ordinance amending the Archbald Zoning Map: off Business Route 6 – change C-2 to R-2 from the C-2 Highway Commercial Zoning District to the R-2 Medium Density Residential Zoning District. Roll call vote, all in favor. Motion carried.

Motion by Gilgallon, second by Owen to **NOT** draft an Ordinance amending the Archbald Zoning Map: off Business Route 6 – change I-1 to R-2 from the I-1 Light Industrial Zoning District to the R-2 Medium Density Residential Zoning District. Roll call vote, all in favor. Motion carried. Motion by Owen, second by Burke to to draft an Ordinance amending the Archbald Zoning Map: Main St/Kennedy Drive – change entire parcel to R-2, the I-1 Light Industrial Zoning District part of the property to the R-2 Medium Density Residential Zoning District. Roll call vote, all in favor. Motion carried.

Motion by Owen, second by Gilgallon to draft an Ordinance amending the Archbald Borough Zoning Map: First Street – change R-1 to R-2 from the R-1 Low Density Residential Zoning District to the R-2 Medium Density Residential Zoning District. Roll call vote, all in favor. Motion carried.

Motion by Owen, second by Grandinetti to draft an Ordinance amending the Archbald Borough Zoning Map: Columbus/Peggy Drives — change S-1 to R-1 from the S-1 Special Purpose Zoning District to the R-1 Low Density Residential Zoning District. Roll call vote, Mancuso, Burke, Gillion againist, Owen, Grandinetti, Hart, Simon for it. 4-3 vote for it, motion carried.

Motion by Gilgallon, second by Hart to draft an Ordinance amending the Archbald Zoning Map: Salem Road – change entire parcel to IAC, the RC Resource Conservation Zoning District part of the property to the IAC Interchange Activity Center Zoning District. Roll call vote, all in favor. Motion carried.

Motion by Gilgallon, sedcond by Hart to draft an Ordinance amending the Archbald Zoning Map: Power Blvd – change R-1 to I-2 from the R-1 Low Density Residential Zoning District to the I-2 Heavy Industrial Zoning District. Roll call vote, Mancuso, Burke, Gilgallon, Grandinetti, Hart, Simon for it, Owen againist. 6-1 vote for it, motion carried.

Motion by Owen, second by Gilgallon to draft an Ordinance amending the Archbald Zoning Map: Eynon-Jermyn Rd. – change I-1 to S-1 from the I-1 Light Industrial Zoning District to the S-1 Special Purpose Zoning District. Roll call vote, all in favor. Motion carried.

Motion by Owen, second by Mancuso adopting a Resolution authorizing "No Parking" on the southerly side of Line Street between its intersection with Main Street and its dead end. Roll call vote, all in favor. Motion carried.

Motion by Gilgallon, second by Owen adopting a Resolution authorizing submission of DCED Multimodal Transportation Fund grant application to continue streetscape southerly along Main Street. Roll call vote, all in favor. Motion carried.

Motion by Owen, second by Grandinetti adopting a Resolution authorizing submission of a DCNR grant application in the amount of \$175,218.75 for the Veterans Monument Park Project. Roll call vote, all in favor. Motion carried.

Motion by Grandinetti, second adopting a Resolution authorizing submission of a Greenways, Trails and Recreation Program grant application in the amount of \$116,000.00 for the Veterans Memorial Park Project. Roll call vote, all in favor. Motion carried.

Motion by Grandinetti, second by Owen authorizing the submission of a Lackawanna County 2019 Arts and Culture Municipal grant application in the amount of \$500.00 for musical entertainment for the Eynon-Archbald Lions Club Harvest Festival to be held in the Fall. Roll call vote, all in favor. Motion carried.

Motion by Gilgallon, second by Owen authorizing the purchase of food and refreshments for the Memorial Day Program for a cost not to exceed \$600.00. Roll call vote, all in favor. Motion carried.

Motion by Grandinetti, second by Owen to adjourn. All in favor, motion carried.
