Motion by Owen, second by Burke to accept Reports – Treasurer, Building Inspector, Controller and Mayor's Report. All in favor, motion carried.

Motion by Owen, second by Gilgallon authorizing payment of May HNB General Fund bills totaling \$113,212.15, Capital Projects Account bill in the amount of \$15,116.67 and DPW Truck Account bill in the amount of \$50,662.00. Roll call vote, all in favor. Motion carried.

Motion by Owen, second by Gilgallon adopting a Resolution Authorizing submission of a Multimodal Transportation Fund Program Grant application in the amount of \$310,000.00 on behalf of SLIBCO for construction of the extension of East Street. Roll call vote, all in favor. Motion carried.

Motion by Owen, second by Gilgallon authorizing execution of a Cooperation Agreement with SLIBCO relating to Archbald Borough's submission of a Multimodal Transportation Fund Program Grant application for the construction of the extension of East Street. Roll call vote, all in favor. Motion carried.

Motion by Grandinetti, second by Gilgallon to approve the KOZ in the Valley View Business Park until December 31, 2026. Roll call vote, Mancuso, Burke Gilgallon, Grandinetti, Hart and Simon for it, Owen against. 6-1 vote, motion carried.

Motion by Gilgallon, second by Burke amending the existing Valley View Business Park Cooperation Agreement with SLIBCO in order to extend the KOEZ time period until December 31, 2026. Roll call vote, Mancuso, Burke Gilgallon, Grandinetti, Hart and Simon for it, Owen against. 6-1 vote, motion carried.

Motion by Gilgallon, second by Hart to adopt a Resolution changing the timing of Borough mandatory contributions to the Archbald Non-Uniformed Pension Plan to coincide with each payroll period to satisfy the Borough's obligations pursuant to the provisions of Act 205 of 1984, known as the Municipal Pension Plan Funding Standard and Recovery Act, as amended. Roll call vote, all in favor. Motion carried.

Motion by Owen, second by Grandinetti adopting a Resolution authorizing the placement and removal of traffic signs to improve parking and traffic flow on and in the vicinity of Pierce Street. All in favor, motion carried.

Motion by Gilgallon, second by Owen approving the revised real estate tax assessment value of \$38,000.00 for the Thomas and Gina Noto property at 314 Riverside Drive, Archbald, PA. Roll call vote, all in favor. Motion carried.

Motion by Owen, second by Gilgallon to allow the Greater Carbondale Chamber of Commerce to utilize the Archbald train station platform on September 14th and September 28th as a stop for the NEPA Valley Wine Tour with the condition that evidence of sufficient insurance for the event must be provided. All in favor, motion carried.

Motion by Owen, second by Gilgallon authorizing the placement of three (3) new street lights on the Eynon-Jermyn road in the vicinity of the Highlands development. Roll call vote, all in favor. Motion carried.

Motion by Owen, second by Gilgallon to adjourn. All in favor, motion carried.
