Motions

Motion by Grandinetti, second by Gilgallon to approve the minutes of July 17, 2019 regular Council meeting. All in favor, Motion carried.

Motion by Hart, second by Mancuso to accept Reports – Treasurer, Building Inspector, Controller and Mayor’s Report. All in favor, Motion carried.

Motion by Gilgallon, second by Burke authorizing payment of July HNB General Fund bills totaling \$292,390.97, Capital Projects Account invoice in the amount of \$253,310.45 and 2018 DPW Truck Account bill for \$8,570.00. Roll call vote, all in favor. Motion carried.

Motion by Mancuso, second by Burke to adopt a Resolution appointing Laura Lewis to Archbald Borough Council until the first Monday in January 2020 to fill the vacancy created due to the death of Joseph Simon. Roll call vote, all in favor. Motion carried.

Motion by Gilgallon, second by Mancuso to appoint Mark Trently to the position of Archbald Borough Emergency Management Coordinator to fill the vacancy created by the death of Joseph Simon. Roll call vote, all in favor. Motion carried.

Motion by Grandinetti, second by Mancuso to adopt a job description for the position of “DPW Laborer”. Roll call vote, all in favor. Motion carried.

Motion by Hart, second by Mancuso to adopt a job description for the position of "Construction Code Official, Zoning Officer and Code Enforcement Officer". Roll call vote, all in favor. Motion carried.

Motion by Gilgallon, second by hart to appoint Brian Dulay to the position of "Construction Code Official, Zoning Officer and Code Enforcement Officer" at a starting wage of \$45,000.00 per year plus benefits. Roll call vote, all in favor. Motion carried.

Motion by Hart, second by Mancuso to appoint Zakery Sawyer a Special Police officer from August 22, 2019 to December 31, 2019 provided he is to be used only to replace a full time regular officer who cannot work due to allowable time off and not to exceed 33 shifts. Roll call vote, all in favor. Motion carried.

Motion by Gilgallon, second by Hart to adopt a Resolution authorizing submission of a Local Share Account, Monroe County Program grant application on behalf of the Archbald Community Ambulance and Rescue Squad in the amount of \$41,781.42 for a Power Pro Ambulance Cot/MTS Power Loader. Roll call vote, all in favor. Motion carried.

Motion by Mancuso, second by Hart to adopt a Resolution authorizing submission of a Commonwealth Financing Authority grant application for a Mass Notification Warning System. Roll call vote, all in favor. Motion carried.

Motion by Grandinetti, second by Gilgallon acknowledging receipt of the revised Eligibility Certification for Entry Level Police Officer. All in favor, motion carried.

Motion by Burke, second by Gilgallon to adjourn. All in favor, motion carried.
