# Archbald Borough Council Meeting Wednesday, June 17, 2020

The meeting was called to order at 7:05 pm by President Brian Gilgallon. A moment of silence in remembrance of Barry Trevelin was followed by the Pledge of Allegiance. Roll call Burke, Owen, Mancuso, Simon, Moran, Ossont, Gilgallon and Mayor Barrett present.

## **Public Input**

Brian Gilgallon, President of Council read emails sent by Collen Gedrich stating her concern for the feral cat problem and offered information to humanely trap feral cats in the neighborhoods. She also offered to help with the problem. Councilwoman Simon, a member of the Feral Cat Committee, also stated she has collected information on places to bring the feral cats to be spayed/neutered. Mayor Barrett asked who is responsible for the cost of the services. Mr. O'Connor, Borough Solicitor, stated they are working on an ordinance for this matter.

Jan Siefring sent an email asking about statements Mr. Mancuso made at the work session on dog waste in the parks and people trespassing in the parks while they are closed due to CoVid-19. Mr. Gilgallon stated they will monitor the amount of waste in the parks as they re-open. Mr. Mancuso replied that he was driving by and was unable to find the person he thought was walking a dog towards Staback Park when he returned.

Cindy Houser emailed concerns over the recycling in the borough. She also asked about paving roads in the borough and not just patching. She claims Ash St., between Wayne St. and Carbon St. to be one of the worst roads in the borough. Mr. Gilgallon addressed her paving concerns, stating the borough does not have a grant to pave roads but they do have a plan, in the initial planning phase. The borough will be working with the Borough Engineer to address the roads in need.

On the recycling issue, Mr. Gilgallon explained how some contracts in other nearby towns pay their hauler to collect & transport recyclables and explained the Archbald contract, which the borough DPW collects recyclables and transports them to Lackawanna County Recycling. The problem being the owners of the Lackawanna County Recycling Center does not have enough inmates to work and sort recyclables after releasing most prisoners. The borough is meeting their mandate for recycling and the Lackawanna County Recycling Center is our designated drop off site. Mrs. Owen questioned if some boroughs/towns can join together and pressure the owners of the recycling center or call a State Representative and Senator Blake to put pressure on the owners.

Nancy Edmunds asked who owns the recycling center for the record. Mr. Gilgallon responded that Mr. Louis DeNaples either owns or runs the center. Gilgallon also stated the extra work DPW puts in collecting recyclables and yard waste.
