The Honorable Judge Laura Turlip gave the Oath of Office to Mayor Barrett preceding the Reorganization meeting.

The meeting was called to order at 6:17 pm by the Honorable Mayor Shirley Barrett. The Pledge of Allegiance was followed by a moment of silence. Roll call. Burke, Owen, Mancuso, Lewis, Moran, Ossont, Gilgallon and Mayor Barrett were present.

A nomination by Tom Mancuso second by Francis Burke to elect Dave Moran as President of Council. Roll call. Burke, Owen, Mancuso, Lewis, Moran in favor. Ossont and Gilgallon against. Dave Moran has been elected President of Council in a 5-2 vote.

A nomination by Dave Moran second by Tom Mancuso to elect Erin Owen as Vice President of Council. Roll Call. Burke, Owen, Mancuso, Lewis, Moran, Ossont and Gilgallon in favor. Erin Owen has been elected Vice-President of Council in a 7-0.

Mayor Barrett turned the meeting over to President Dave Moran.

A nomination by Tom Mancuso second by Brian Gilgallon to elect Mike Ossont as Pro-Tem. Roll call. Burke, Owen, Mancuso, Lewis, Moran, Ossont and Gilgallon in favor. Mike Ossont has been elected Pro Tem in a 7-0.

**New Business:**


The 2022 Archbald Borough Calendars will go out this week.
